

**TO THE HONORABLE BOARD OF COMMISSIONERS OF BERRIEN COUNTY:** Your County Personnel and Human Services Committee respectfully recommends the adoption of the following:

**RESOLUTION**

**WHEREAS**, the Southwest Michigan Planning Commission has requested GIS parcel data for the purpose of exploring the potential for land use scenario planning in places that are not major metro areas in Berrien, Van Buren, and Cass County's; and

**WHEREAS**, the Southwest Michigan Planning Commission is providing said data to CommunityViz who will be performing the Lincoln Institute grant case study; and

**WHEREAS**, the final project will be the development of a guidebook to summarize key steps of the scenario planning process to be made publicly available; and

**WHEREAS**, the guidebook will describe data needs, how to develop forecast totals, model set up and architecture, calibration and impact modeling and each section will describe how the model was developed for the case study site.

**WHEREAS**, the document will be graphically-oriented and supported by text, tables and maps appropriate for conveying necessary information, and the document is anticipated to be between 15-20 pages in length.

**WHEREAS**, Southwest Michigan Planning Commission accepts full responsibility for the security and use of this "in-kind" GIS parcel contribution which combined is valued at \$43,146; and

**WHEREAS**, to facilitate this transaction a Berrien County GIS Digital Data Restriction Agreement will be executed between Berrien County and a representative from Southwest Michigan Planning Commission.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** that the Berrien County Board of Commissioners does hereby authorize the release of the 2020 Berrien County parcel data to the Southwest Michigan Planning Commission to be used in conjunction with CommunityViz for a Lincoln Institute grant case study and authorizes the Chairperson to execute the Digital Data Restriction Agreement.

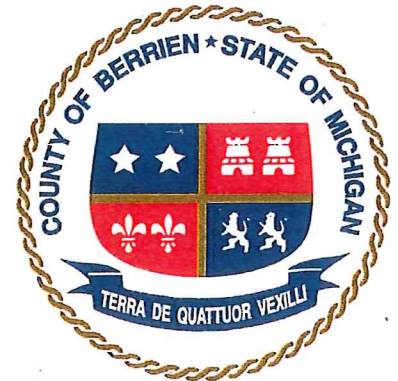
