OTHER BUSINESS:

Commissioner Freehling read the following statement into record regarding a conflict of interest:

Prior to September 12, 2020, I never held any membership interest in Baroda Valley Farms, LLC. From its formation until my husband Patrick's death in 2019, the LLC's membership interest was held solely by Patrick, his father, and one other. After Patrick's death, his interest in the LLC was transferred to the other two members. My daughters and I received no compensation for the transfer of that interest, and we took no interest in the LLC. In 2020, the members of the LLC informed me of their desire to discontinue their involvement in the LLC. Not wanting to see my husband's LLC simply dissolved, I agreed to have the whole of the membership interest in Baroda Valley Farms, LLC transferred to me, which occurred on September 12, 2020.

I have knowledge that, prior to my taking the membership interest, Baroda Valley Farms LLC rented equipment to REV Excavating, and that such equipment may have been used for County drain projects. Therefore, I intend to abstain from all contracts between REV and the County. It is also my intention that Baroda Valley Farms LLC will not permit the use of any of its equipment or other assets in any County projects during my service on the Berrien County Commission.

I will continue to apply the practice that, if I have any reason to believe anyone close to me is directly or indirectly associated with County business, I will research all the facts and will opt to abstain if there is any doubt about their participation in any matter brought to this Board.

Vice Chairperson Scott asked about the Board members having more oversight of the Road Department on the bid process and the RFPs with more details on the bid specs in regards to the Finance and Administration Committees. Administrator Brian Dissette explained and addressed the concerns. Discussion was held.
